

## OUR CORPORATE PRIVACY POLICY

This privacy policy explains how our organization uses personal data you provide us. The following information is provided only for the website <https://www.pebospa.com/> and not also for third-party websites accessible through hyperlinks (links) contained in the Website.

### WHO IS THE CONTROLLER OF PERSONAL DATA?

### WHICH PERSONAL DATA DO WE COLLECT?

Each time a user uses or views our website we collect the following data:

**Navigation data.** The computer systems and software procedures used to operate a website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This category of data includes the IP addresses or domain names of computers and terminals used by users, the addresses in URI/URL (Uniform Resource Identifier/Locator) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters related to the user's operating system and computer environment. **Cookies.** Cookies are small text files that sites visited by users send to their terminals, where they are stored to be retransmitted to the same sites on the occasion of subsequent visits. Cookies are used for different purposes, they have different characteristics and they can be used both by the owner of the site you are visiting and by third parties. ### PURPOSES OF PROCESSING, LEGAL BASIS, PERIOD OF RETENTION OF DATA AND NATURE OF THE PROVISION

- **LEGAL BASIS:** legitimate interest (Art. 6, par. 1 lett. f) and recital 47 GDPR): processing is necessary for the pursuit of the legitimate interest of the controller or third parties, provided that the interests or fundamental rights and freedoms of the data subject which require the protection of personal data do not prevail, taking into account the reasonable expectations of the data subject based on his or her relationship with the controller. Activities strictly necessary for the operation of the site and the provision of the navigation service on the platform.
- **DATA RETENTION PERIOD:** up to the duration of the browsing session. Please, refer to the Cookies policy of the site.
- **NATURE OF THE CONTRIBUTION:** it is necessary in order to allow navigation of the website.

### TO WHOM WE COMMUNICATE YOUR DATA?

Your personal data are communicated:

- to collaborators and employees authorized and instructed by the Data Controller in the context of their skills and duties;
- to providers of services offered through the Site or related to its operation who act as data processors (e.g. web hosting service, newsletter service);
- to third-party companies or consultants in charge of installation, maintenance, updating and, in general, management of the hardware and software of the site;

Apart from the cases described above, personal data will not be disclosed, disseminated, transferred or otherwise transferred to third parties for illicit purposes or not related to the purposes described above and, in any case, without making appropriate information to data subjects and acquiring their consent, if required by law.

It is without prejudice to any communication of data at the request of the Judicial or Public Security Authority, in the manner and in the cases provided by law.

### TRANSFER OF YOUR DATA TO THIRD COUNTRIES

Your personal data may be transferred abroad, even in non-EU countries, after verification of the standard contractual clauses approved by the European Commission (art.46 GDPR) or the binding rules for the company (art.47 GDPR), or, in the absence thereof, by virtue of one of the derogatory measures referred to in art. 49 GDPR.

## YOUR DATA PROTECTION RIGHTS

Our company wishes to ensure that you are fully aware of all your data protection rights. Each user has the right to:

**The right of access** – You have the right to request from our company copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that our company correct any information that you believe to be inaccurate. You also have the right to request our company to complete information that you believe is incomplete.

**The right to cancellation** or restriction of processing - You have the right to request that our company delete your personal data.

**The right to restrict processing** – You have the right to request that our company limits the processing of your personal data in the cases indicated in art.18 GDPR;

**The right to object to processing** – You have the right to object to the processing of your personal data by our company for marketing and profiling purposes;

**The right to data portability** – You have the right to request that our company transfer the data we have collected to another organization, or directly to you, in the cases indicated by art. 20 GDPR.
